- NFA disclaimer for short barrel rifles (under 16")

LWRCI’s DOMESTIC NFA POLICY CUSTOMER ACKNOWLEDGMENT

(You must read and sign the acknowledgement and return to LWRCI by email< bnelson@lwrci.com >, by fax to 410-228-1775, or by mail to the above address prior to any action being taken by LWRCI to transfer any NFA item.)

1. LWRCI will sell NFA items to qualified customers only when all provisions of the National Firearms Act are met, and there are no Local or State Regulations preventing such sale. LWRCI does not give legal advice, and are not responsible to determine your eligibility to own or possess an NFA item. LWRCI’s duty is to determine the eligibility of the FFL/SOT transferee.
2. On receipt of order LWRCI requires a faxed or mailed receipt of a current SOT and FFL of the dealer for whom the NFA item is to be transferred to.
3. Before LWRCI will process an NFA transfer, the item must be paid for in full, even if the item is backordered or awaiting BATFE action.
4. LWRCI is not responsible for any delays in shipping that arise from actions or delay of action by the BATFE regarding any NFA transfer.
5. LWRCI is not responsible to collect or pay any NFA transfer taxes assessed by the BATFE. Transfers from LWRCI will be to an NFA SOT holder in which transfer taxes are exempt, or to a qualified Government entity that is NFA Transfer Tax Exempt.
6. If the order is cancelled before BATFE processing there will be a 25% restocking fee assessed. Orders already processed with BATF E cannot be cancelled.

Having read the above, I _____ agree and understand the LWRCI NFA Policy. I understand that payment must be made in full prior to the processing of any NFA transfer paperwork. I authorize LWRCI to debit my credit card for payment in full for the item ordered, per the above policy. If payment is made by other means, I understand that no action will be taken on the NFA transfer until payment is received by LWRCI. LWRCI is not responsible to determine my qualification to own an NFA item, LWRCI’s role is to qualify the Licensed Federal Firearms Licensee and transfer the item to that licensee. I understand that all National Firearms Act Regulations, Rulings, and Laws apply to this purchase.
